Users of this website are informed that the personal data provided through this form will be treated in accordance with this Privacy Policy.

The data provided will be treated with the following purposes:

- 1. Referral of commercial communications by any means. Through these communications, users will be informed about the different services offered by EMPRESA, as well as the events organized by it.
- 2. To process registrations swimrun event. In this case, the images or videos made of the participants in a particular way during its development may be published on the entity's website, on their social networks, in corporate magazines, bulletin boards and any other similar means of communication owned by them, with the purpose of promoting said event. If you do not want the image to be captured through videos or photographs, the interested party must refrain from participating in the SWIM RUN event. Likewise, the data of the participants (name and surnames) may be published in the same media, in order to publicize the participations, classifications or results of the event.

In addition to the above, if the user expressly consents, their data will be transferred to the entity HEAD SPAIN S.A. with address at C / Roger, 65-67 5º-6º, 08028-Barcelona, dedicated to the commercialization and distribution of all types of sport products and their accessories, for the remission of commercial communications, through any means, of the products and services it offers.

The user accepts the processing and inclusion of the data collected during the completion of this form in accordance with the above.
